It has come to our attention that unauthorized parties are fraudulently impersonating **BORSUMY FIRE ENGINEERING CO. LTD.** by sending fake emails (See Appendix I & II) and providing fraudulent bank account details to deceive our clients and partners.

We hereby declare that:

1. Any communication or transaction requests* originating from email addresses not officially in **borsumyfire@gmail.com** , **main@borsumyfire.com.hk** and **borsumy_fire@yahoo.com.hk** are FRAUDULENT.
2. All legitimate bank account information* of **BORSUMY FIRE ENGINEERING CO. LTD.** is exclusively provided through official channels, including signed contracts or verified company documents. All of our Bank Account No. have NO CHANGE since Year 2010, and there is NO PLANNING to change. Any personal/ other company name/ non-HONG KONG bank accounts claiming to be associated with our company are UNAUTHORIZED.
3. We have reported this incident to the relevant authorities (including Hong Kong Police, Cybercrime units) and are taking legal action against the perpetrators.

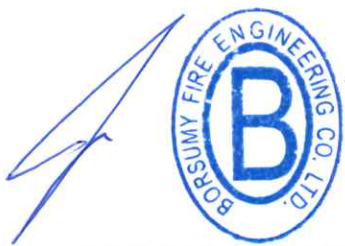
